





1. WHEN EXISTING SHOWER BALL VALVE NEEDS TO BE REPLACED WITH A NEW MODEL 190.92.04.30 BALL VALVE, FIRST REMOVE AND CHECK OLD BALL VALVE, THEN:

WASHER OR NOT.

HORIZONTAL CONFIGURATION (STANDARD)
